Aircraft, including without limitation the pre-flight, fueling, loading, entry into, exit from, taxiing, engine run-up, take off, flight, landing, emergency procedures or other air or ground operations of Blue Skies Flying Services, Inc. Aircraft.
- The term personal injuries as used above is fully intended by me to include without limitation, conscious suffering, pain and suffering, medical expenses, death and funeral expenses.
- 3. The terms of this Release are also fully intended to cover those times when I am a passenger, pilot or pilot receiving instruction from another, pilot, a certified flight instructor or an independent contractor certified flight instructor with Blue Skies Flying Services, Inc. in Blue Skies Flying Services, Inc. aircraft or while I am on, about or around Blue Skies Flying Services, Inc. aircraft on the ground.

I warrant I have completely read and understand the terms of this Release and that I voluntarily accept this Release for the purpose of making a full and final release of the parties named herein. The terms of this Release are not a mere recital, but are fully intended by me to be binding upon me and the other parties to this Release.
